## 3. Jeremy Morris - Public Works

### 1. United Way Campaign

Jeremy Morris explains the United Way employee campaign and asks the Board if they want to have the County participate again this year. Commissioner Boyd said he feels United Way is a good organization, he is in support of it. He said we need to make sure we are careful with how we present this to the employees so no one feels pressured. Commissioner DeGroot said he is in support of it. Commissioner Boyd asked Mr. Morris if he'd like the head up the campaign. He said, yes. The Board agrees by consensus to have the County participate.

Lisa Jackson addresses the Board. Commissioner DeGroot motions. Commissioner Boyd seconds. Commissioner Boyd asks Ms. Blain if she has reviewed this. Ms. Blain said she has and it is allowed per our policies. Unanimous vote. Approved.

2. Veba Contribution For Non-Represented Employees Discussion Commissioner Boyd said it was his understanding the cap was \$1400, the Veba contribution is 50%, \$700 per non-represented employee. Commissioner DeGroot said, that is the consensus we came down to. Alyssa Gentry said, she felt the discussion was around people not opting out and the Board wanted there to be more more incentive. Sue Murphy said policy 318.2 states it will be established during open enrollment time and shall not exceed the cost of the high deductible health plan. Ms. Gentry said the high deductible health plan is \$1531, so it couldn't exceed half of that. Commissioner Boyd said he'd like to follow the policy, establishing it during the open enrollment period. Ms. Blain asks if the policy states when it applies. She said there is some grey area, you could establish it in October and not apply it until the next fiscal year. Ms. Murphy said she'd like to see the policy changed so it's included in the language for budget assumptions. Ms. Murphy said we'll have to make a retroactive adjustment. Commissioner DeGroot said he wants to follow policy and he wants to make sure it's enticing as possible for people who are choosing. Ms. Blain brought up the point of making sure employees are made aware. Commissioner DeGroot said he is concerned that this will take effect for represented employees July 1 and he wants it effective for the nonrepresented at the same time. Commissioner Boyd said he wants to follow policy, he feels it is an earned benefit. Commissioner DeGroot said, why don't we follow policy, make it effective July 1, 2019 and 50% of the high deductible policy which is \$765. Commissioner DeGroot moves. Commissioner Boyd seconds. Unanimous vote. Approved.
