Dear Voter,

If you choose to return your voted ballot by fax **(541-885-6757)** or email (elections@klamathcounty.org), the following three items must be received in the Klamath County Elections office **no later than 8 p.m.** (Pacific Standard Time) on Election Day, **November 03, 2020**:

1. Completed and signed form **SEL 531** (printed on reverse side).
2. Voted **ballot** (front and back).
3. **Signed Signature Identification Envelope** (with identification label & signature showing).
